DESCRIPTION OF WORK: Project includes, but is not limited to: Painting of exterior surfaces of entire complex. Work includes all scaffolding, wall washing, surface preparation, minor wall patching, protection of surfaces not included for painting, landscape trimming, protection and replacement, removal and replacement of roofing to accommodate scaffolding.

BIDDER QUALIFICATIONS: To allow the University to evaluate bidders, each bidder must submit with its bid, a Contractor's Special Statement of Experience. This Contractor's Special Statement of Experience must be provided on the Contractor's letterhead. ***If your firm provides inaccurate or incomplete information your firm will be found non-responsive. If your firm receives negative project references they may be found non-responsive.*** To be eligible for consideration of award, the Contractor's Special Statement of Experience must include:

- a. documentation that the bidder has successfully completed at least three (3) multi-story and occupied painting projects within the last five (5) years with a value of not less than \$500,000.
- b. the name, address and current phone number of the Owner's Representative on the three (3) submitted projects.

Bid Security in the amount of 10% of the Lump Sum Base Bid, excluding alternates, shall accompany each Bid. The Surety issuing the Bid Bond shall be, on the Bid Deadline, listed in the latest published State of California, Department of Insurance, list of *Insurers Admitted to Transact Surety Insurance in This State*.

A **MANDATORY Pre-Bid Conference** will be conducted on **April 28, 2009**, beginning promptly at **10:30 A.M.** Participants shall meet at the Haas School of Business, Bank of America Plaza, plaza is on the lower level, Haas is located on the east side of the Berkeley campus, off of Gayley Road. Only bidders who participate in the Pre-Bid Conference in its entirety, will be allowed to bid on the Project as prime contractors.

NOTE: Prospective bidders will find that parking on campus may be difficult. The Owner recommends that you allow **ample time** to drive to the campus, find a parking space, walk to and locate the starting point from which the **MANDATORY** Pre-Bid Site Visit will begin. Prospective bidders arriving late after the **MANDATORY** Pre-Bid Site Visit has commenced (i.e., more than 15 minutes after the published starting time.) will not be allowed to submit a bid as a prime contractor for this project. Prospective bidders must be present for the **entire** Pre-Bid Site Visit.
